PRESENTATION

The post-COVID-19 pandemic and the advent of AI have altered the perspective on the imminent future increasing the perception of risks and unknowns of a digitally shaped society. Operating since the dawn of the digital revolution, the Infopoverty World Conference has punctually recorded the most significant turning points of this era, highlighting projects and best practices worthy of the attention of the United Nations system, within whose framework it was born, with the mission of promoting the achievement of the MDGs and SDGs through ICTs and new technologies.

Now a new phase is opening up, brought by a new generation of digital natives and by the exploitation of new technologies that have become the formative paradigm of development. In this context, addressing this heterogeneity of new, often unethical, instances, induced more by private forces, which, by offering the infrastructure and operating platforms, in fact determine their uses and purposes, has become of the utmost importance and cannot be delayed any longer. The powerful advent of A.I. has turmoiled the digital processes: it is now crucial to understand how to act to ensure human rights and provide e-welfare for all.

How should we steer the impetus of AI to orient it towards overcoming inequalities, climate emergencies, and challenging instances?

How to address the paradoxical binomial between digital excellence and its diverted use, it being at the basis of a struggling achievement of the SDGs putting the protection of human rights on the back burner?

How to attest that ICTs and AI serve as effective responses to current challenges only if they undergo ethical examination and are prone to human needs?

On these premises, addressing the topic "Al turmoils digital processes: how to act to ensure human rights and provide e-welfare for all?", the 23rd Infopoverty World Conference will convene as a think-tank, gathering distinguished experts to showcase pioneering projects aimed at achieving the UN 2030 Agenda and beyond. To do so, the conference will first draft the map of asynchronism to draw knowledge-sharing policies allowing economic, political, and technological fences to be overcome, to later focus on e-welfare4all and the critical gaps to be covered to attain it, namely food security, health and education to launch an appeal for investments on best practices to lead the transition towards an ethical, sustainable and SDGs inspired digital Society leaving no one behind.


